Safety-Driven

Silica Competent Person Training

Per the requirements of the Respirable Crystalline Silica Standard (29 CFR 1926.53), employers are required to provide specified control measures at locations where crystalline silica presence measures above 25 micrograms per cubic meter.

This facilitated and interactive 2 Day Training Course allows participants to gain the knowledge they need to assure the effectiveness of their company's silica compliance program, and to understand the requirements and responsibilities of a silica "competent person" on construction sites.

OSHA 10 & 30-hour construction

The basics required by OSHA in our regularly scheduled 10 & 30hr course include applicable OSHA standards, current regulatory changes, guidance for navigating the OSHA website and what to do when OSHA visits. Frequently, company specific courses are scheduled which focus on the safety needs of that company's workforce and work practices.

OSHA Hazard Communication/Global Harmonization Program

This class updates members on the new hazardous material handling aspects of the Global Harmonization effort. New Safety Data Sheets are reviewed and new labeling requirements are covered.

OSHA specific classes

Taught by OSHA Region VI training center, classes are offered in Albuquerque throughout the year. Included courses: OSHA 510, OSHA 500, OSHA 511, OSHA 501, OSHA 502, OSHA 503. In addition, classes are available covering ergonomics, permit-required confined space, electrical standards, fall protection, scaffolding, cranes, derricks and material handling, excavation, trenching and soil mechanics and more.

First Aid/CPR/AED

This 8-hour class includes the latest thinking on proper and acceptable CPR and first aid methods. Also included are familiarization guidelines for using AEDs. Attendees receive a 2-year and 3-year certification card.

Lead-Safe Certification and Refresher training

This 8-hour course taught by EPA Accredited Trainers provides the renovation, repair and painting lead certification and 4-hr. refresher course for those who've attained their RRP Certification.
